Memorandum of Understanding

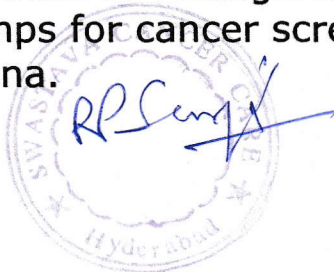
This MOU is entered into between:

Swastava Cancer care -Hyderabad hereinafter called Swastava
represented by Shri RP SINGH-IPS (Retd), President

and

Malla Reddy Cancer Hospital (A unit of Chandramma
Educational Society) hereinafter called MRCH represented by
Dr Ch Bhadra Reddy. Chairman

Swastava Cancer care is a registered society -NGO, actively
involved in organising awareness programmes for the youth, a
flag ship programme of youth empowerment on cancer 'REACH
THEM YOUNG' assigned by Department of Education,
Government of Telangana(DEO, Hyderabad and Jeedimetla)
and camps for cancer screening of people in districts of
Telangana.





Malla Reddy Cancer Hospital(A unit of Chandramma Educational Society), a not for profit organisation which has now set up a full-fledged Cancer hospital & Research Centre – MRCH and is fully geared up for most modern cancer treatment facilities with experienced Medical, Surgical & Radiation Oncologists in place for cancer treatment with state of art equipments, most modern Operation theaters and Radiation Oncology facilities was approached by Swastava Cancer care to work together under joint banner in the areas of common interest like:

- Organising awareness camps & screening jointly in villages identified by both parties in the Districts in Medchal and around within 100 KM radius from the time of getting clearance from Department of Health and Family Welfare, Government of Telangana to go ahead with Screening operations. This screening will be for both male & Female – male screening includes oral, Lung & cancers while women screening includes Cervical, breast & Oral cancers.
- Government schools covered jointly with a two-pronged approach – creating awareness on tobacco & Alcohol and establish NO TOBACCO schools as per the COTPA and girl children to be given awareness on Menstrual and Physical Hygiene & problems of HPV advising them to visit the MRCH for HPV vaccinations given at subsidized price.
- Concurrently promote need for HPV vaccine to be given to girl children between 8 to 20 years of age to prevent onset of cervical cancer through social media with a mission to eradicate cervical cancer.
- Conduct dental camps in the same schools where we conduct awareness programmes since oral hygiene prevents oral cancers

- Facilitate a Geriatric cancer service to cater to the needs of senior citizens, collaborate with Swastava to conduct awareness camps for senior citizens, screening men for oral, lung & prostate cancers and women for breast, oral & cervical cancers besides handling other cancers if traced. Swastava will facilitate identifying of locations, arrange venue and all other logistics for organizing awareness & Screening camps while MRCH will provide clinical support to screen the last incumbent for pre-cancerous stage, collect swabs, PAP smear slides and other samples like Blood samples as required for prostate antigen and like at a subsidized price.
- Enter into tripartite agreement with International Society for Geriatric oncology – Switzerland arranged & organized by Swastava. Requisite charges of 3000 Swiss francs for training of our doctors and membership fee of 300 Swiss francs, total 3300 Swiss francs (about Rs.250,000.00) has been generously agreed to be paid by MNCH.
- We shall work with like-minded organizations like Red Cross, Helpage International and Heritage to focus on senior citizens as these organizations have infrastructure and data banks of senior citizens which will be accessed by Swastava.
- Social welfare department of Government of Telangana which has residential schools for SC, ST, BC, EBC & MINORITIES has approached Swastava to screen children in the schools for cancers (275,000 students). Swastava & MRCH can take up this programme and thus facilitate pediatric cancer care & necessary clinical support will be extended by MRCH from time to time with mutual understanding.
- Both MRCH & Swastava have the option to project each other as joint operators in their respective websites.

- All post screening investigations mentioned above will be as per tariff by cash payment or as per their eligibility under Government schemes, insurance, CGHS, ECHS, ESI etc

Swastava will identify locations, infrastructure in select villages and mobilize women for screening while MRCH will provide necessary clinical support.

Cases identified for FNAC, Biopsy, Mammogram and other investigations will be done in MRCH at approved tariff and patients will be admitted for procedures under cash, Insurance, Arogyashree or ESI schemes as the case may be.

For Screening camps & Awareness camps, all physical arrangements shall be done by Swastava in schools, villages and other identified locations and MRCH will provide Necessary clinical support.

The camp will be organized in the joint names of Swastava cancer care, MRCH and sponsors if any.

MRCH and Swastava, either independently or jointly, will observe all important cancer related special days like World cancer day, World tobacco day, Breast Cancer & Cervical Cancer Month etc.

MRCH and Swastava either independently or jointly will formulate Research proposals in such a way that the results will be useful to the cross section of society particularly for people at the bottom of Pyramid. Rights on Research findings will be applicable accordingly.



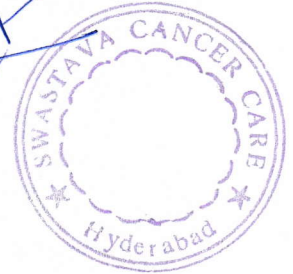
